RESTRICTED ARTICLES

Certain commodities such as combustible liquids, compress gases, corrosive liquids, explosives, flammable liquids, flammable solids, magnetized materials, oxidising materials, poisons, polymenzable materials, radioactive materials, noxious or irritating substances and articles possessing other dangerous characteristics may cause damage unless properly packed, marked and labelled for air shipment.

Articles described above are hazardous and may only be carried as cargo professionally packed. Many ordinary household items, such as aerosols, perfumes and cigarette lighters (see below for examples) are also NOT PERMITTED as cargo and MUST NOT be included. If you include any of these items they WILL be spotted during cargo scanning. The offending items will be removed and the remainder of your cargo detained. The Civil Aviation Authority will be informed and may take formal action against you. PLEASE BE WARNED!

BY SIGNING THE DECLARATION ON THE REVERSE OF THIS FORM YOU ARE ADVISING US THAT NO SUCH ITEMS ARE INCLUDED. YOU MAY BE SUBJECT TO PROSECUTION IF THIS LATER TURNS OUT NOT TO BE TRUE.
